As you know there has been talk that I would be moving back to Wisconsin. I am writing you today to put my 2 weeks notice in. I finally got the go ahead to move back to Kenosha. As of right now the kids are staying with their Dad not sure if that is permanent or not. Trial was delayed do to my health conditions.

I had surgery yesterday (They bumped my surgery up almost a full month because of being in the ER July 2 & 3) and had my ovaries removed. The doctor said it was one of the worst cases he has seen of Endometrious. They found a 4.9 cm chocolate cyst on my right ovary at the beginning of July when I was in ER and during surgery found that Endo had attached itself to quite a few of my organs including my colon so therefore they were not able to burn it off for fear of burning my important organs. The doctor said it was pretty bad. I need to be near my support system & family which is here in Kenosha because I will be shocked into menopause so that hopefully all the Endo will die off for 6 - 9 months. After that they put me on hormone replacement therapy.

I will really miss everyone at OES and I appreciate all the things OES has done for me. I have been applying for full time school district jobs here but I have to get healthly first to be a good employee and a healthy Mom. I would love to be able to put you guys down as a reference if you dont mind?

I do plan on being there the first day of school to see my children off.
