Dear Board of Education Members,

It has been a privilege to work for the Oregon School District as a regularly employed full-time custodian for twenty-six years. I have been a loyal and dedicated employee and have always worked to contribute all that I could for the benefit of the District. I am a long-time resident and tax payer of the Oregon School District. My children attended Oregon schools and my grandchildren currently attend or will attend Oregon schools as well. I have enjoyed my time working with the District staff and the students of our community. However, I have reached a point in my life where retirement might be the best decision for maintaining my health and well-being. Since I will not reach Medicare eligibility for four years I am concerned that retirement will create a financial burden for my family. I am proposing a retirement incentive agreement which will relieve some of my concerns and also offer a savings in salary costs for the school district as well. If the Board would approve this proposal, my last day of employment would be December 29, 2017.

I am asking that the District provide me a with a post retirement stipend in the amount of \$30,000.00. I am making this request per the provisions of Article 18.9 of the collective bargaining agreement and understand that this stipend would be in lieu of the retirement incentive provided in Article 18.7. I have attached a breakdown of the costs and savings of my proposal. I appreciate your consideration of my request

Extension Addendum to Assistant Superintendent's Contract

The Board of Education ("Board") of OREGON COMMUNITY UNIT SCHOOL DISTRICT #220 and Adam Larsen ("Assistant Superintendent") agree to extend and amend the Assistant Superintendent's Contract (the "Contract") entered into between the Board and the Assistant Superintendent on October 16th, 2017 as follows:

A. <u>EMPLOYMENT AND COMPENSATION</u>

- **9. BENEFITS.** Director shall have the following benefits in addition to the salary above:
 - (A) **Health/Dental Insurance Coverage**. The Board shall pay 95% of the cost to the Principal of the District's group hospitalization/medical health insurance coverage both individual and family. The Board's share of such paid health insurance shall not be included as income to the Principal for purposes of federal and state income reporting.

This clause shall be effective retroactive to July 1, 2017 on Board approval of the addendum.

The Board and the Assistant Superintendent agree that there have been no oral modifications to the Assistant Superintendent's Contract, and that the modifications stated herein shall be effective immediately. All other terms and conditions of the Contract, as amended, shall remain in full force and effect.
