ATM PLACEMENT AGREEMENT

This Agreement made and entered in this 17th day of January 2017 by the following parties, Stillman BancCorp NA ("Bank"), Meirtran, Inc. ("ATM Owner") and Oregon CUSD 220, ("ATM location owner").

RECITALS

WHEREAS, Meirtran, Inc occupies certain premises located at Oregon High School, 206 S tenth Street, Oregon, IL hereinafter referred to as "said Location"; and

WHEREAS, Stillman Bank and Meirtran Inc. desire to operate and maintain an Automated Teller Machine ("ATM") in said location; and Bank agrees to provide funds and operational assistance and

WHEREAS, ATM location owner is willing to grant an approval to place said ATM at the placement location upon the terms, covenants and conditions set forth herein.

AGREEMENT

Purpose

Oregon CUSD 220 hereby grants Meirtran Inc the right, privilege and license to place, maintain, and operate said ATM at a mutually agreed upon site in said Location with Stillman Bank trademark. This license is subject to Meirtran Inc obtaining at its sole cost and expense any and all regulatory approvals, if any, which may be required to carry out the purpose of this Agreement.

ATM Functions

The parties agree that said ATM shall perform only the following functions:

Cash Dispensing, Balance Inquiries and Funds transfers between customer accounts

Installation of Equipment

Oregon CUSD 220 shall approve all plans and specifications for said ATM to be placed at the location, which approval shall not be unreasonably withheld. Oregon CUSD 220 shall allow ATM Owner access to electrical service already on the site. Meirtran Inc and Stillman Bank agree that they will facilitate the connection and maintenance of said ATM with no cost to Oregon CUSD 220. All legal requirements and code changes will be followed and shall be responsibility of Meirtran Inc.

Maintenance

Any and all repairs, including those due to vandalism, weather or normal wear and tear to ATM shall be the sole responsibility of Meirtran Inc.

Oregon CUSD 220 shall be indemnified for any and all losses for ATM machine and monetary losses due to theft or destruction of machine.

Termination

Request for removal of said ATM shall be made by Oregon CUSD 220 with 90 day window to remove.
