- 8. Meeting called to order by Wills at 6:30 p.m.

- 14. Dr. Wills read aloud the district mission statement "educate students to be to be lifelong learners who are productive, responsible citizens."
- 15. Club Presentation: OHS 9th grade team presented and included Yordy, Davidson, Radostits, Poser and Cremeens. The program was started during the 2008-2009 school year. Currently has eight staff members. Team presented a historical overview of freshman F from 07-08 through current day. There was a gradual decrease except for years 13-14 to 15-16. During this time, the team experienced a number of staff changes on the team. The team meets once a week during plan period to discuss student, interventions and plan parent contacts. Difficult conversations held regarding homework and test taking policies to create consistency. The team schedules parent-teacher conferences and present a "contract" for the students and

parents to review and sign, which lays out a goal for student achievement for the year. The team tries to attend 8th grade IEP reviews to prepare for incoming freshman needs. The team organizes and conducts Freshman Orientation. The team gave an overview of the chance to graduate based on a freshman's grade point average at the end of their first year.
