1. Meeting called to order by Dr. Wills at 5:30 p.m.
2. Roll call, present were Wills, Griffin, Haugh, Baker and Zimmermann. Absent were Buck and Guzman

12. The School Board Members stood and read aloud the affirmation followed by Dr. Wills who read aloud the district mission statement “educate students to be to be lifelong learners who are productive, responsible citizens.”
13. Recognitions:
 - Yvonne Drake recognized staff who assisted with the clean-up of her classroom following the water damage at DLR Junior High. Dr. Mahoney recognized the custodial and maintenance staff who put in the extra hours on the clean-up.

15. Motion by Guzman, second by Haugh to approve the consent agenda as presented. Mahoney reviewed a few of the bills for the month of February. Roll call vote. All voted aye. Motion carried.
16. Motion by Guzman, second by Haugh to approve the updated registration fees for the 2019-2020 school year. Roll call vote. All voted aye. Motion carried.
17. Motion by Zimmermann, second by Baker to approve the updated 2019-2020 calendar. Dr. Mahoney explained that the update was to change all Wednesdays to a 2:00 p.m. dismissal for staff meetings, curriculum development and trainings. Roll call vote. All voted aye. Motion carried.
18. Administrator Reports
 - Mrs. Virgil discussed the new initiative for Kindergarten. August 15th and 16th each incoming kindergarten student will have a scheduled 30 minutes to meet with their new teacher and tour the building. Kindergarten teachers will also be conducting assessments at the local preschools in the area. Any incoming kindergarten students not attending a local preschool will have appointments made for screenings.
 - Crandall informed the board on classroom visits to watch student work in rigor and curriculum. Realigned evaluations of student performance will create a more efficient process with less writing. He also discussed the “Stop the Bleed” training, which trained staff to stop a bleed out in the case of an active shooter incident.
 - Dr. Deininger discussed the upcoming change in scheduling as well as college and career readiness for students. The high school will be introducing freshman seminar class as well as pathways. Memo of understanding with Highland Community College to offer remedial math at a college level to high school students so students meet the college level math requirements when they begin school. Dr. Deininger also informed the board the Mr. Josh Nelson has had a 175% increase in student projects for FFA from 2016 to current.
 - The high school wrestling team was recognized for their performance at State over the weekend. Mr. Guzman thanked the administrators and the teachers for their focus on the students. A current wrestler has had obstacles in life, but thanks to administrators and teachers not giving up, the student is on a good path.
