Oregon Elementary School

- Josep Montanola contacted 33 families via 109 phone calls between the hours of 9 am to 6 pm. I helped several parents to handle their anxiety and distress, so the effects on their children could be reduced. Furthermore, I encouraged students to finish their schoolwork. On the other hand, I attended three staff meetings and two Counseling Department meetings, and I also attended one IEP meeting. She facilitated lessons in Pre-K and Kindergarten via zoom, these lessons continued to focus on social skills that had been taught during the school year. Mrs. Stewart provided weekly lessons to 1st, 2nd, and 3rd grade via Class Dojo and Google Classroom as well as joined the class zoom meetings. Mrs. Stewart also had weekly meetings with students and families that she was providing weekly support to during the year. She also attended the grade level data meetings and multiple IEP meetings. Mrs. Stewart also attended several webinars through the ROE and the weekly PD provided by OCUSD.
