### **January 2019 Monthly Report**

#### **Oregon Elementary School**

- Mrs. Stewart conducted 40 individual sessions with students, topics included behavior, self-control, emotion management, and peer relationships. Mrs. Stewart facilitated 8 lunch groups this month with Kindergarten and 2nd grade, topics included goal setting, boundaries, rules and expectations, and peer relationships. Mrs. Stewart also conducted 15 classroom lessons this month in pre-k through 3rd grade, all lessons focused on kindness and empathy. Mrs. Stewart has also been the lead for the Kindness Committee at OES which has been planning activities for The Great Kindness Challenge, due to weather this has been moved to February 4th-11th at OES. Student Ambassadors have been working on posters and promoting the kindness week as well.
- Mr. Montanola met with 49 students individually several times. He ran 16 philosophical discussion groups, 8 social skills groups, two peer conflict group with a total of 96 students and 88 individualized student work in class interventions. In addition to, he taught 20 socioemotional lessons. Furthermore, he ran two parent coaching sessions and taught 10 socioemotional lessons.

### **David L. Rahn Junior High School**

- Mrs. Cermak continues to meet with students individually and in small groups.
- Meetings this month included grade level meetings, Student Assistance Team meeting, student services department, IEP meetings at OES and DLR, and meetings with parents.
- Provided orientation to six new students and their families and one student transitioning back from the Chana Challenge program.
- 8th grade families were invited to high school course selection meeting & appointments were set up for individual course selection

### **Oregon High School**

- Counselors met with students to complete any necessary changes to second semester schedules.
- Two State Scholars were recognized from OHS at the basketball game on January 4th.
- Counselors created a presentation about new courses and highlighted programs for the 2019-2020 school year. This presentation was given by all teachers during Study Hall.
- Counselors individually met with students regarding course requests for the 2019-2020 school year. Parent(s)/guardian(s) were welcome to attend these meetings.
- Highland Community College was at OHS for spring registration paperwork on January 7th. Students completed necessary paperwork to qualify for dual credit.
- Ms. Cremeens attended a PaCE Implementation Leadership Training in Deerfield. OHS is moving towards a PaCE framework over the next few years for ensuring student support regarding post-secondary planning.
