

#### **Technology Survey at Registration**


We started collecting information from families at the time of registration to begin to understand what is available to students at home and what they could bring to school. Some school districts have created bring-your-own-device (BYOD) programs that allow students to leverage their own personal technology during the school day. For schools that have supplied students with devices, schools often wonder what speed and type of Internet access is available to those students when they go home.






The first chart summarizes the Internet access at home, broken down by school. About 9% of students do not have Internet access available to them. The most common types of access include Cable/DSL and Wireless Broadband.

We are presently working with our Internet providers (ICN and Comcast) to see what can be done to provide access to families when students are at home. We have seen some innovative practices at conferences, including supplying 4G hotspots, hanging Wide Area Network (WAN) access points on utility poles, and even equipping buses with access points and parking them overnight in highly-populated areas with low Internet saturation. One data analysis project we are currently investigating is whether we can geocode student address information well enough to determine where our high-needs areas are.



This chart summarizes the same data, but breaks categories down by lunch status. More students from impoverished backgrounds (14.5% versus 3.2%) have no Internet at home. Greater proportions of paid students see satellite or wireless broadband Internet access. This might be expected, given that these are two of the more expensive Internet options available.





Next, we analyze the devices available to students and whether they can be brought to school. Laptops, Android phones, and Apple iPhones are the most commonly-available devices. Few students would be able to bring these devices to school. One interesting response indicated that a student would be able to bring a desktop computer to school.

Very few homes seem to have Chromebooks. A smaller proportion of students can use them in the home, and a smaller proportion yet could bring them to school. This is of particular interest because Chromebooks are a strong contender for serving as the 1:1 device when the district is able to purchase a full fleet. Most families would have no experience with a Chromebook in the home, which might make it important to have training available for families who are struggling to connect the device to in-home wifi



### **StudentTracker Reports**

We have used the StudentTracker project to follow students in their postsecondary enrollments since the 2010-2011 school year. In our initial data file, we went all the way back to the Class of 2004 so we could have historical data from the start. Every November, the National Student Clearinghouse matches our graduates file with current college enrollments and sends us a new report. 




























