#### **StudentTracker Reports**

We have used the StudentTracker project to follow students in their postsecondary enrollments since the 2010-2011 school year. In our initial data file, we went all the way back to the Class of 2004 so we could have historical data from the start. Every November, the National Student Clearinghouse matches our graduates file with current college enrollments and sends us a new report. The new reports, including the Class of 2022 and enrollments from the 2022-2023 school year, are attached.

- Postsecondary, after seeing a post-COVID rebound in 2021, saw a new decline in Fall 2022.
  Decline more pronounced for 4-year schools
- First- to second-year persistence rates remain steady at 80%
- Class of 2018: 24.8% (26 of 105) have completed a degree
- The four community colleges in our area continue to the most frequently attended
- Northern Illinois University is the most popular in-state 4-year school (20 students)
  Recently replaced Illinois State University (19 students)
- UW-Platteville is the most popular out-of-state 4-year school (11 students)
- Aurora University is the most popular private school (8 students)




