PowerSchool Webinar

On Thursday, Dec 13, PowerSchool featured our school district in a national webinar. The target audience was school districts that currently use one of PowerSchool's other products (the learning platform, HR/finance system, or one of the other student information systems that they have acquired). We have used the StudentTracker project to follow students in their postsecondary enrollments since the 2010-2011 school year. Every November, the National Student Clearinghouse matches our graduates file with current college enrollments and sends us a new report. The new reports, including the Class of 2018 and enrollments from the 2018-2019 school year, are attached.

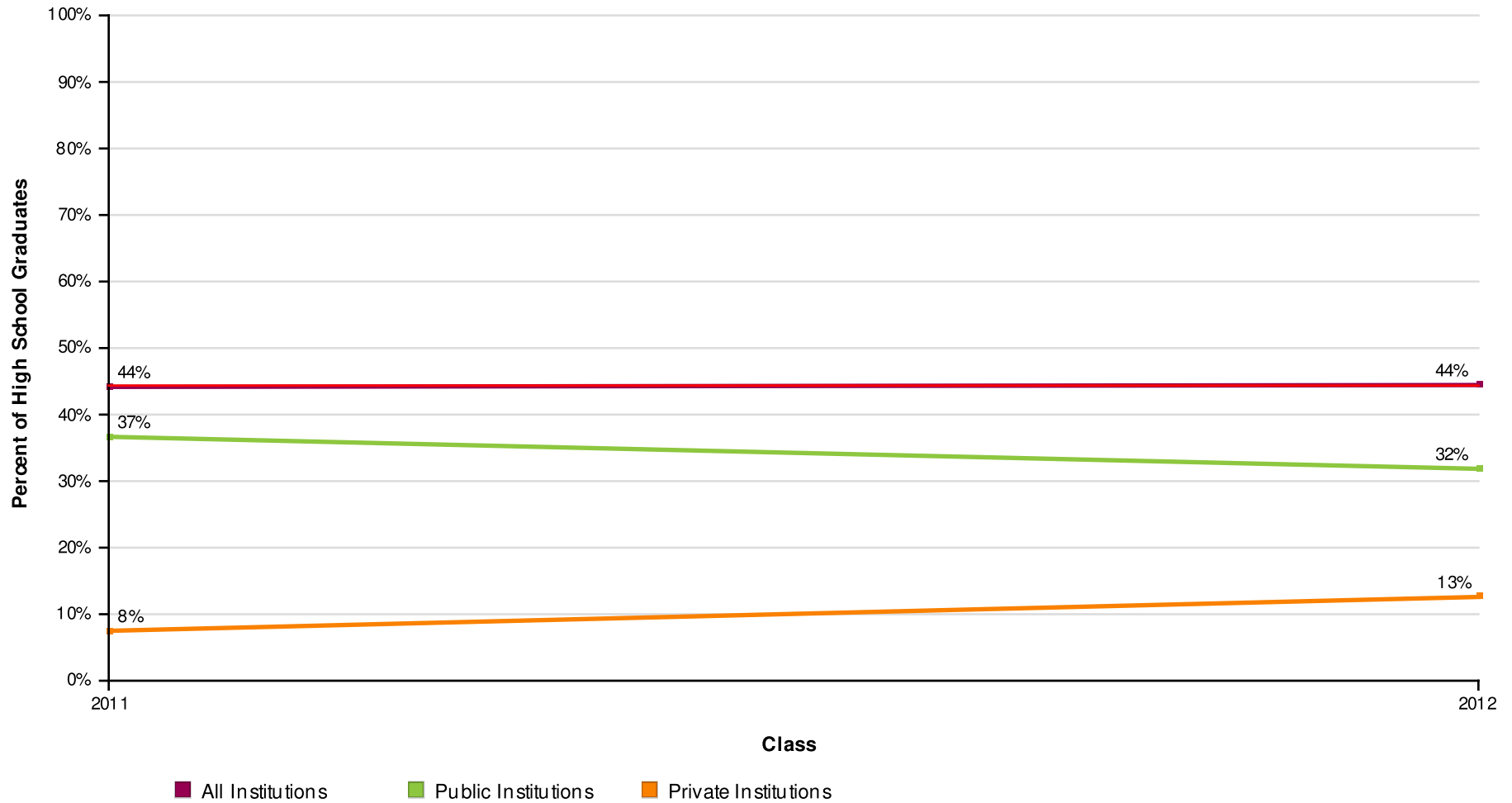

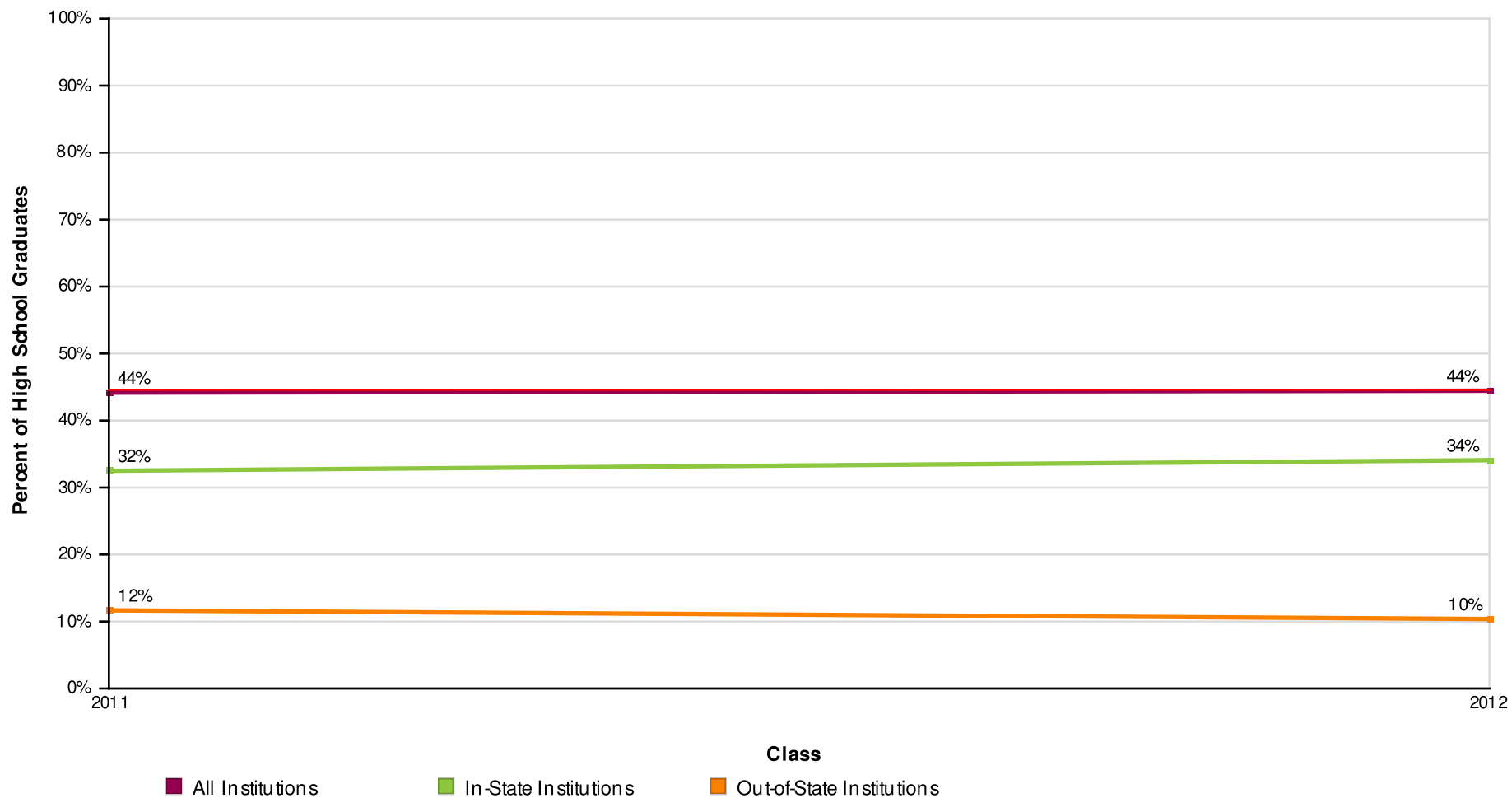

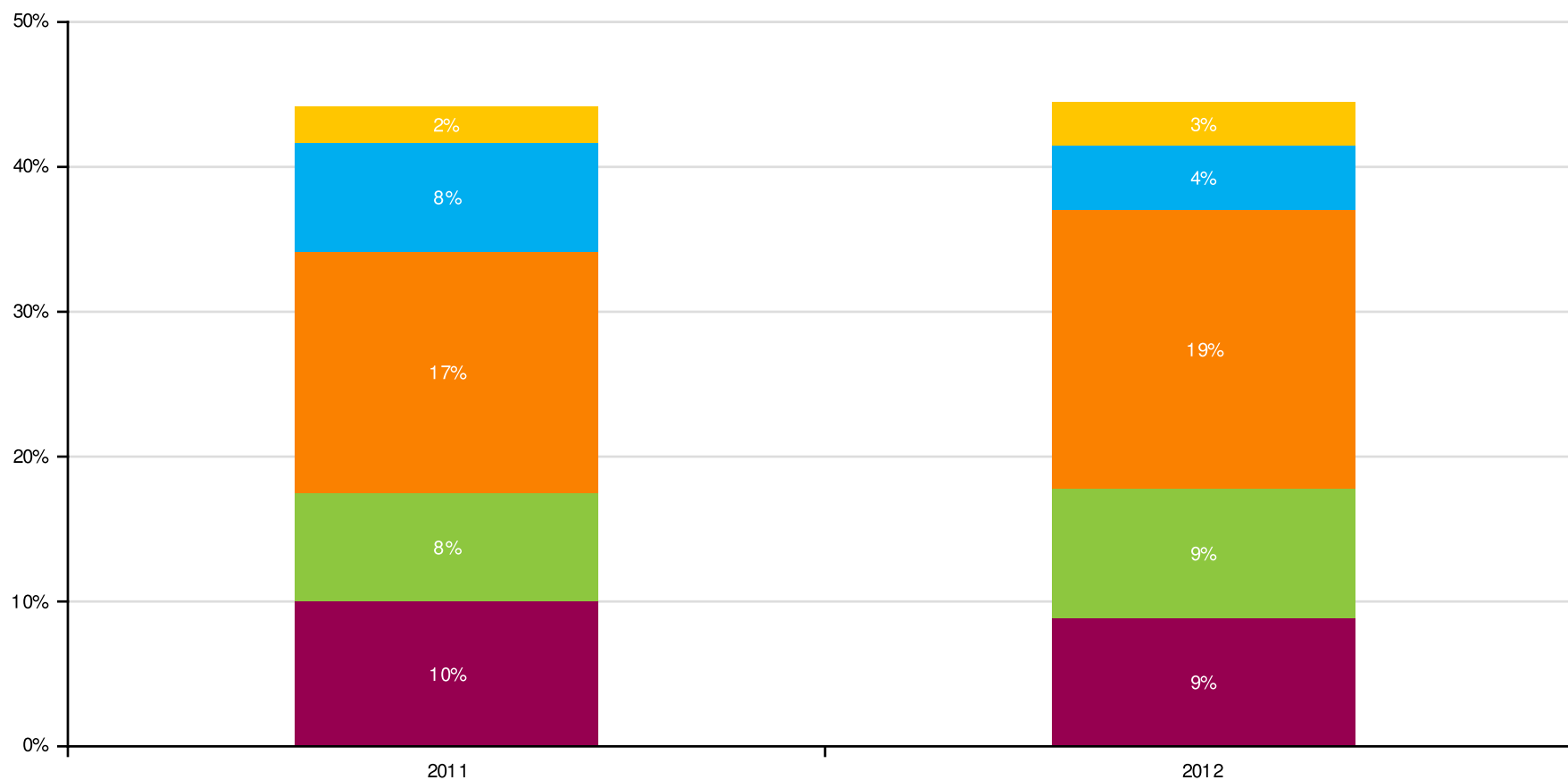

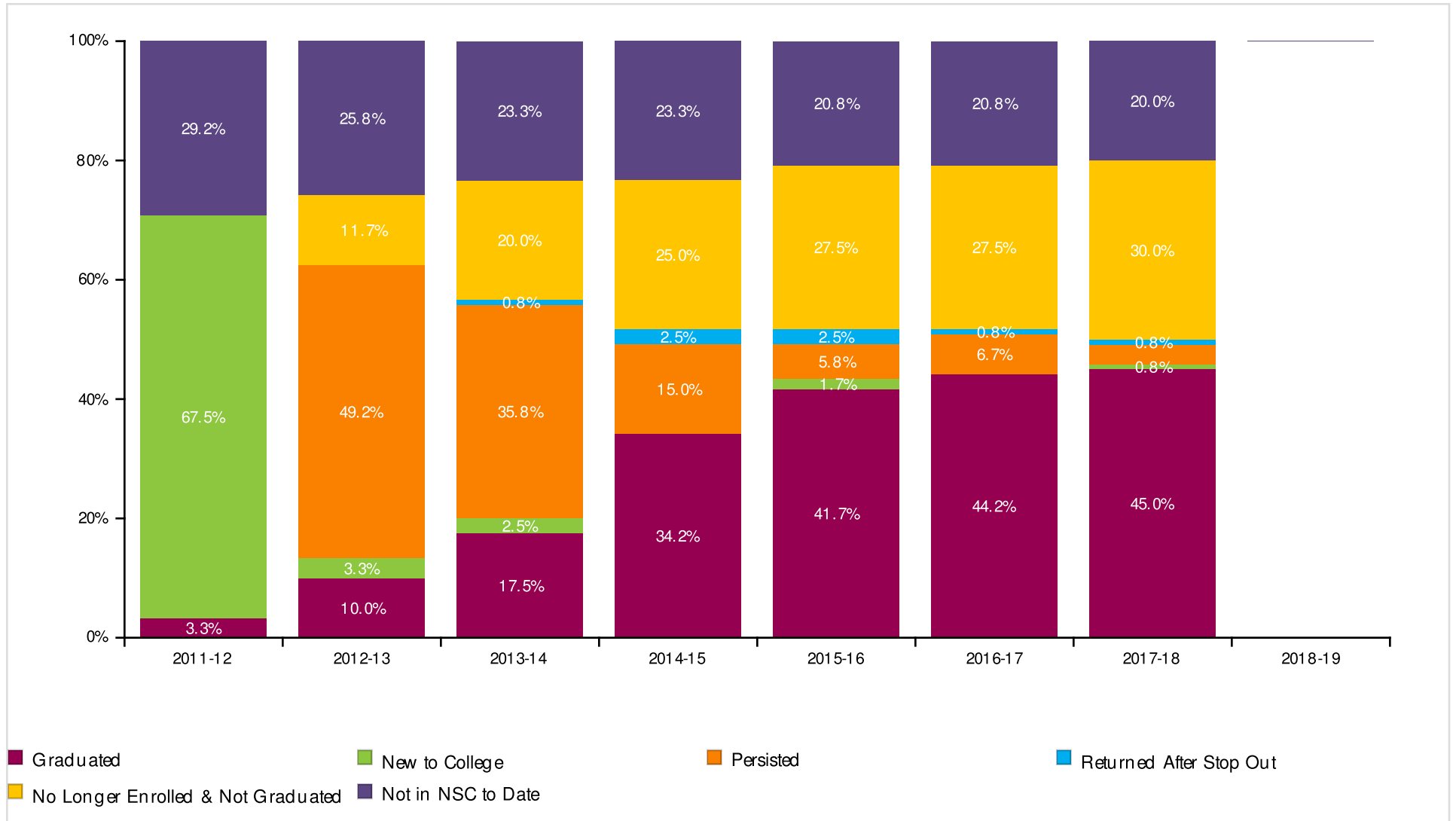

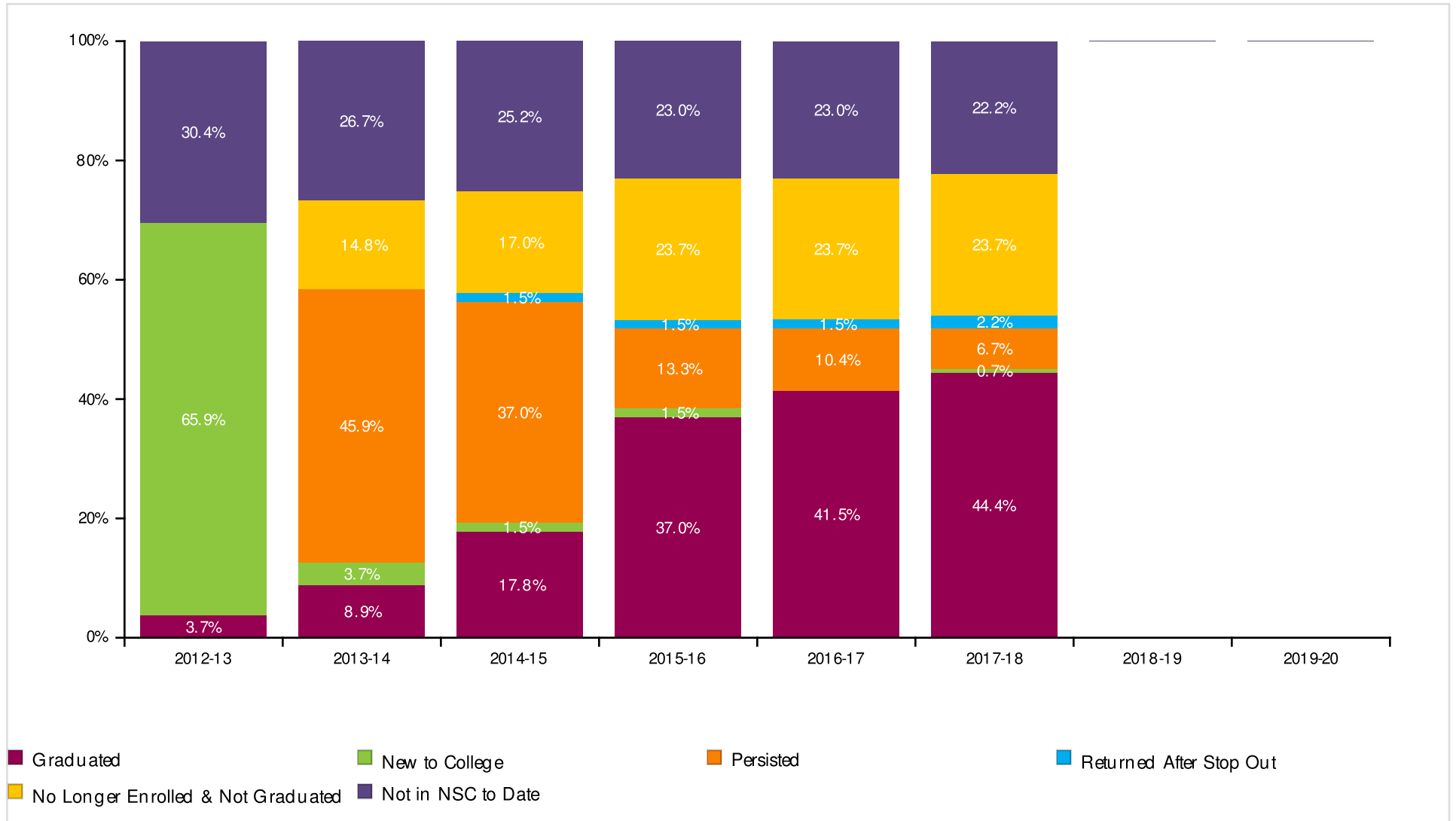

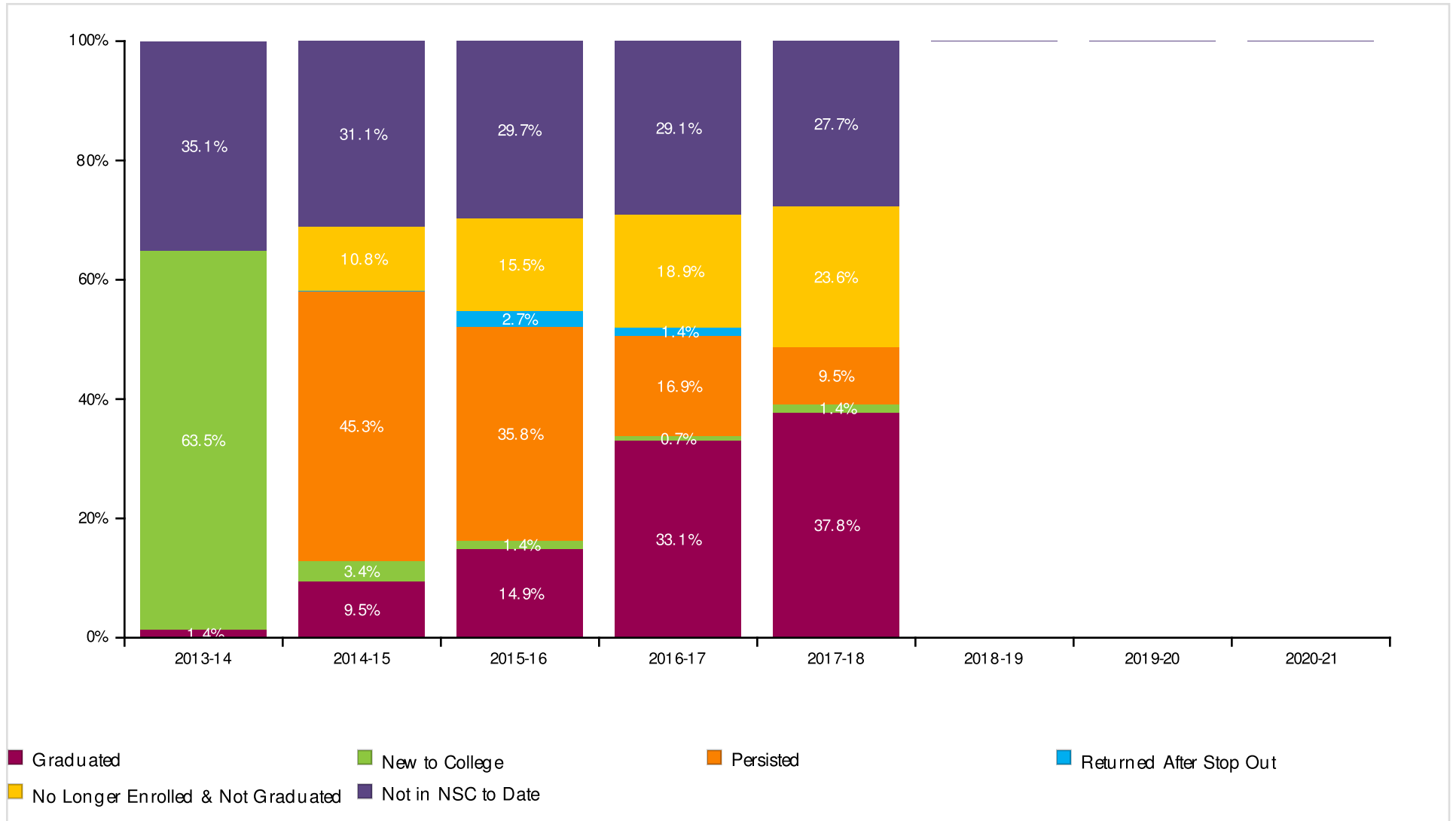

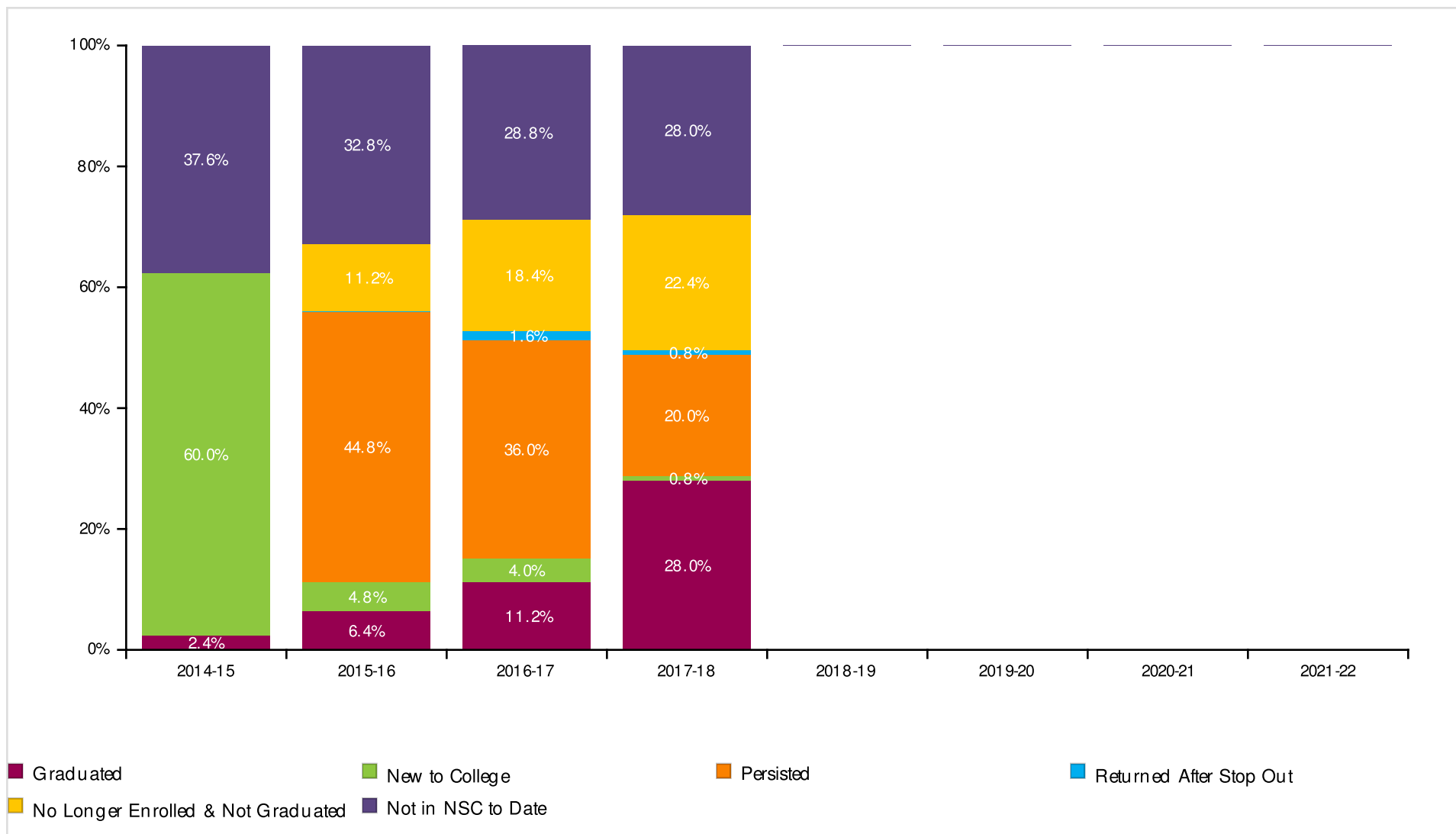

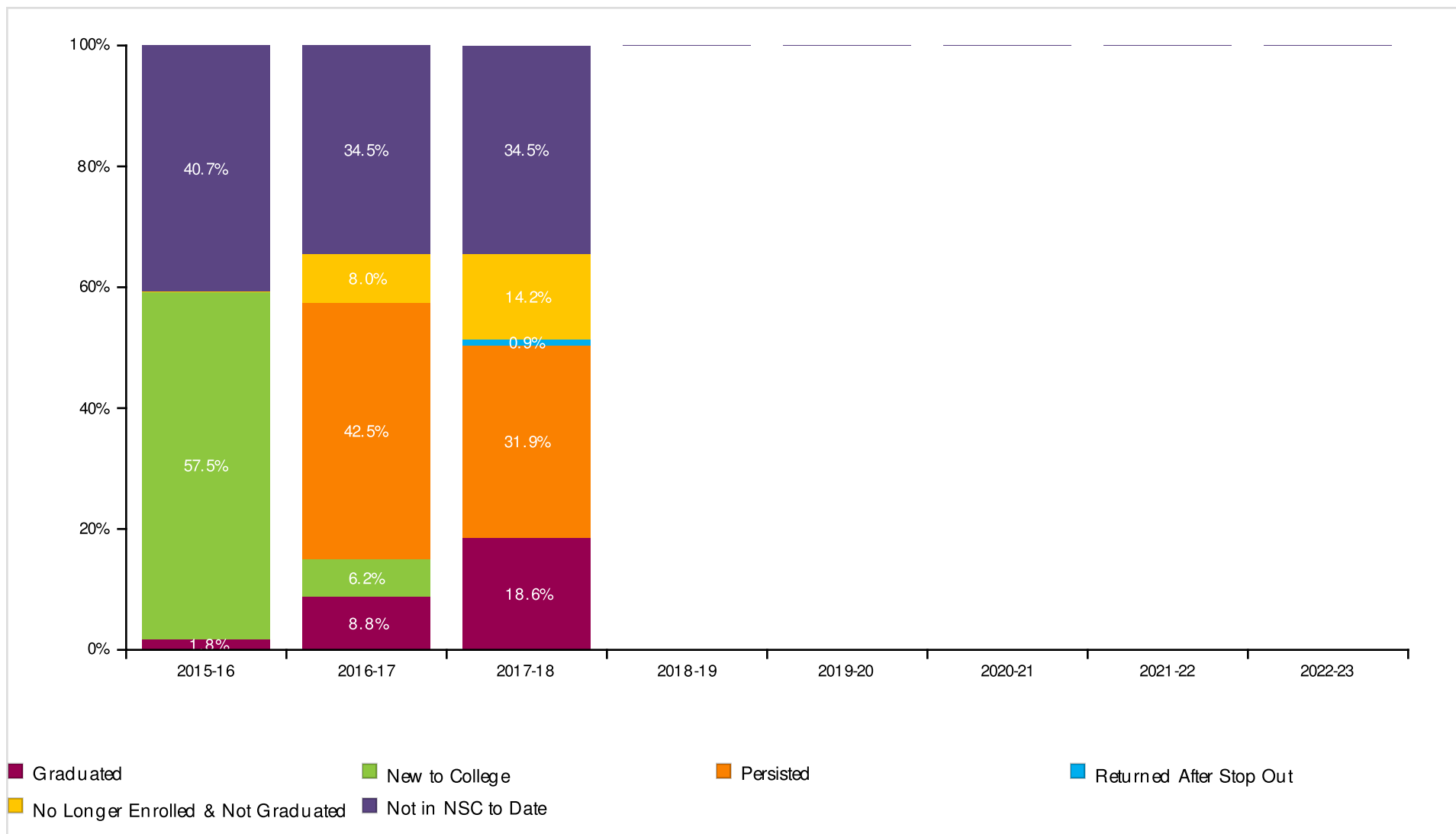

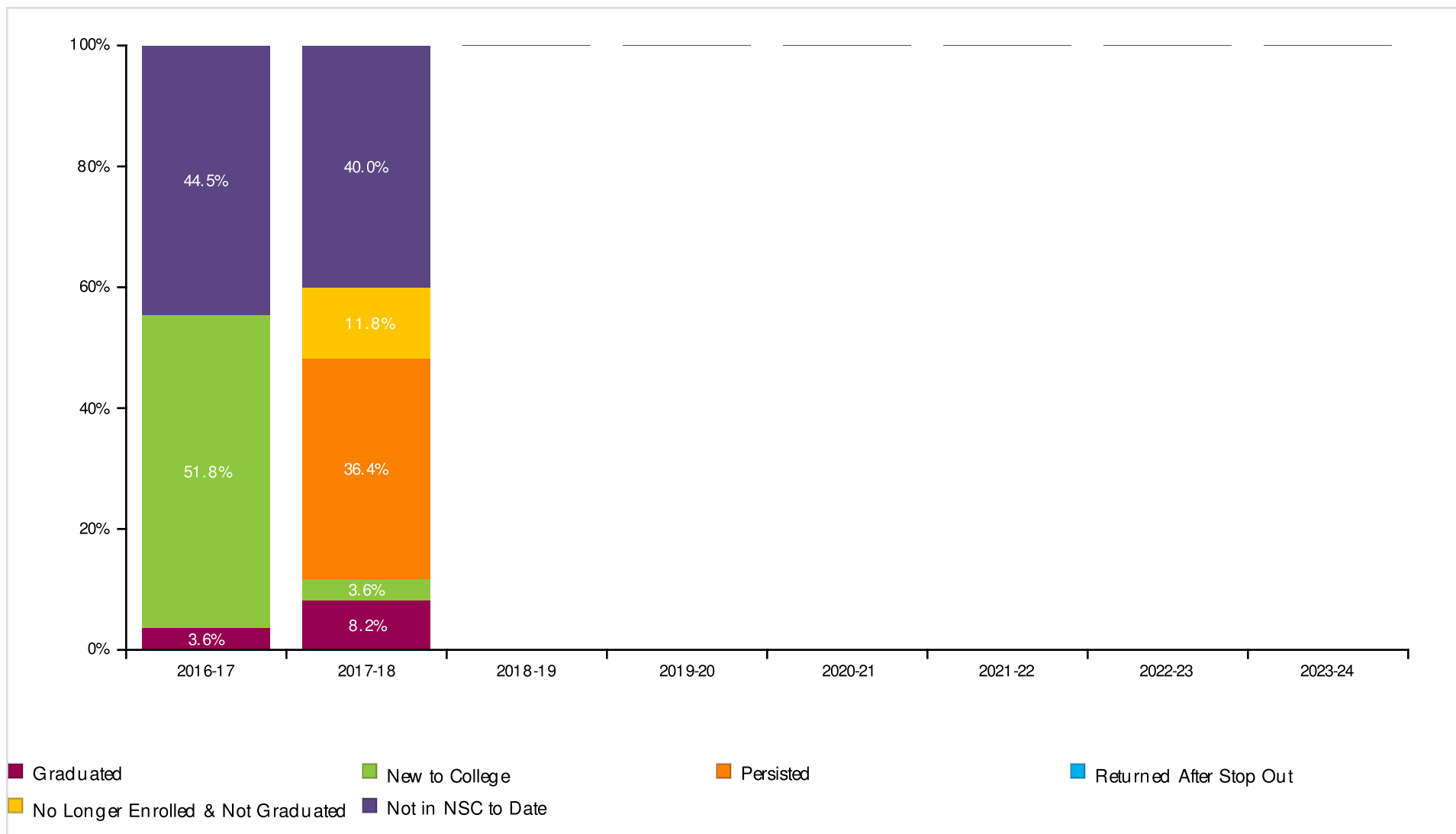

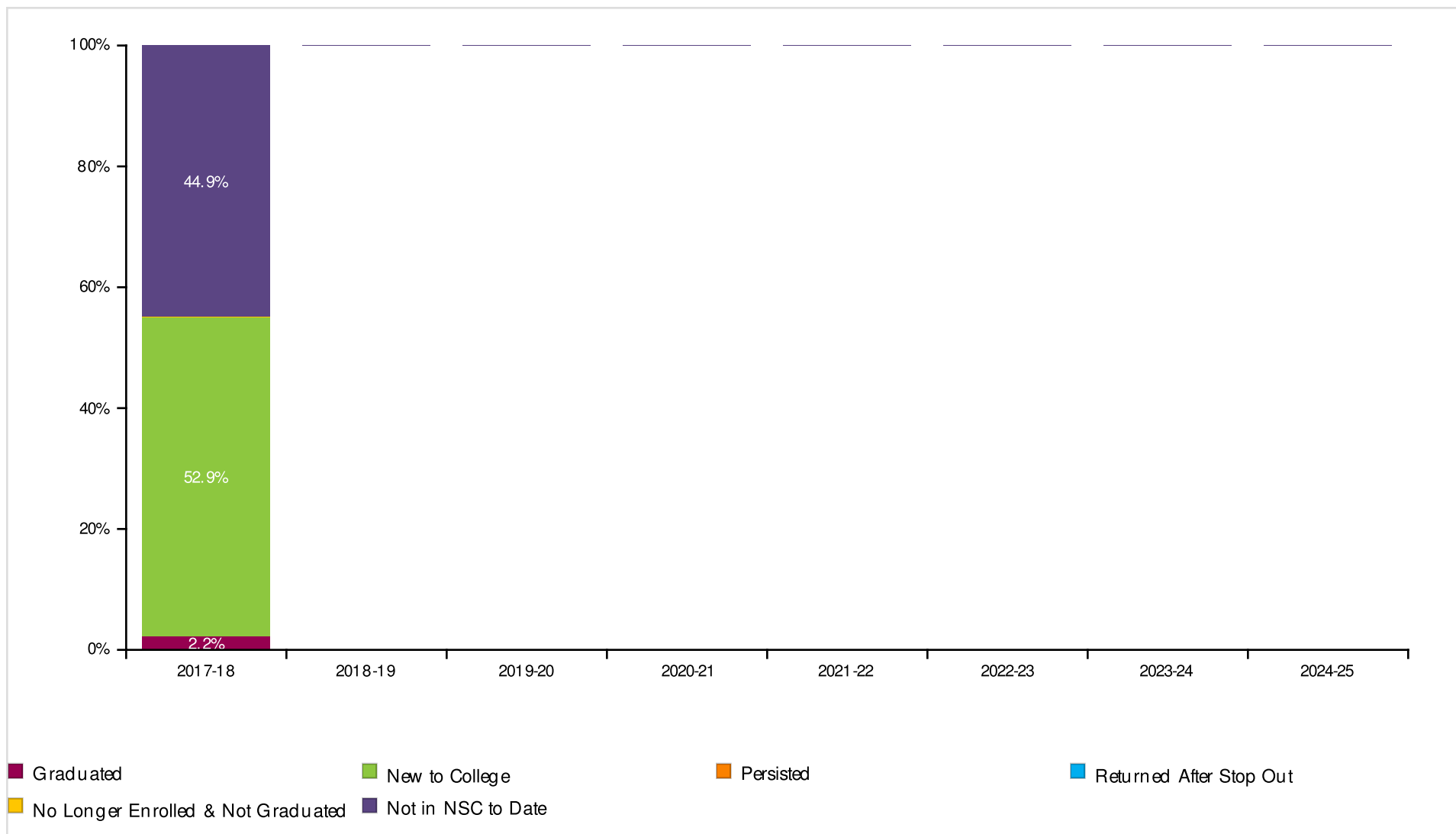

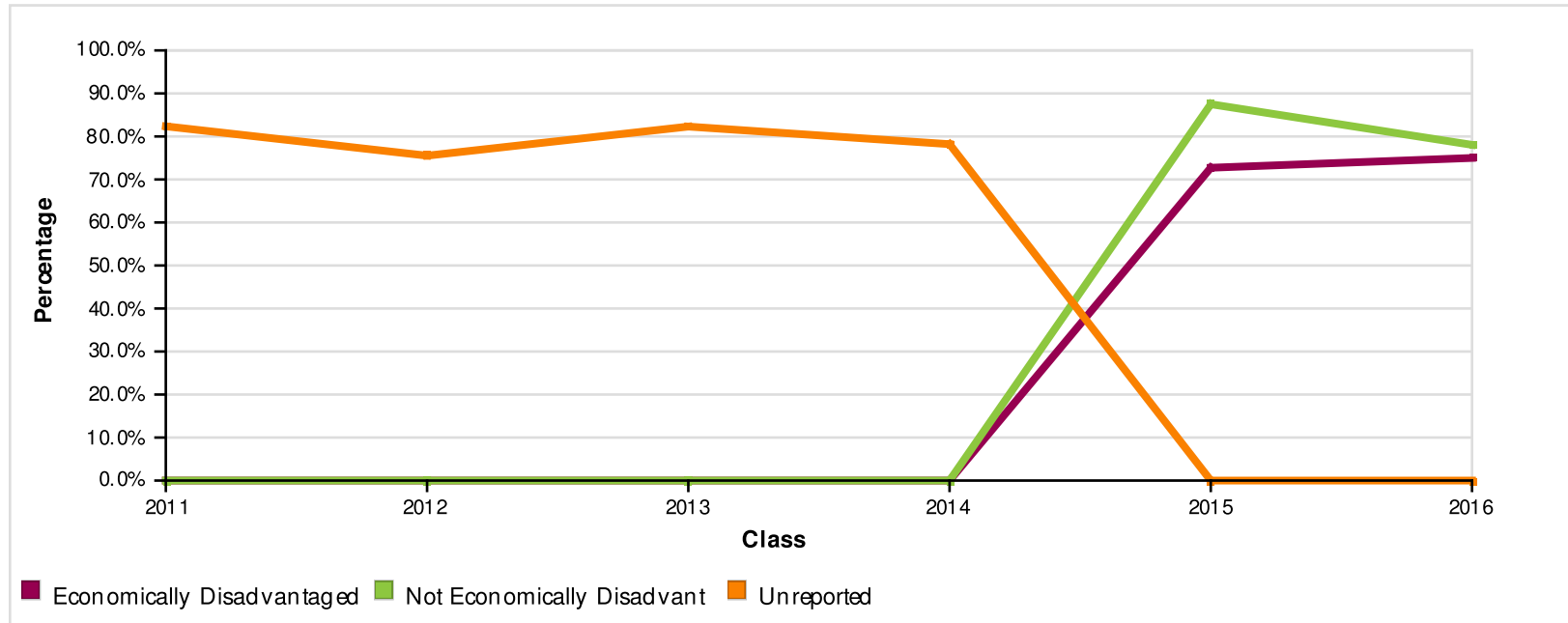
