November 2020 Monthly Report

Oregon Elementary School

- Mrs. Stewart facilitated 51 classroom lessons this month in grades Pre-K through 2nd Grade. We reviewed the Zones of Regulation and coping skills. We also had a lesson on appreciating our Veteran's. Mrs. Stewart also began lessons on Empathy this month during classroom lessons, she also sat in during the virtual Erin's Law presentations in grades Pre-K through 2. During our adaptive pause, Mrs. Stewart continued to provide classroom lessons synchronously with K-2nd grade students as well as follow up with students and families via phone. She also met with 20 students for individual sessions this month and held one group in Mrs. Costa's classroom. Mrs. Stewart attended the virtual Illinois School Counseling Association conference at the beginning of the month, she also attended the following meetings: BSAT, monthly staff meeting, monthly student services meeting, Covid to Calm training, Google Tools meeting, and several remote planning meetings. This month RSAC also completed the required Erin's Law training in all grade levels at OES.
- Mr. Montanola met with 30 students several times for individual counseling. He ran three philosophical discussions. He also taught 35 SEL/ teaching thinking, decision making and problem solving. In addition, he provided 65 individualized student work classroom interventions, and contacted 7 parents via phone call. He worked with 180 remote learners for SEL. He shared animation videos having to do with race, stereotypes, disabilities, and differences. While people in quarantine, he assisted the nursing staff by taking temperatures, and he helped outside with recess.

David L. Rahn Junior High School

- Mrs. Cermak met with students virtually and in person and made one home visit.
- Meetings in November included several IEP meetings, parent meetings, and department meetings.
- Due to staff shortages, Mrs. Cermak provided coverage in office and in classrooms during November.

Oregon High School

- All students at OHS grades 9-11 took practice tests for the PSAT/SAT.
- A representative from the Illinois Student Assistance Commission provided mentoring meeting opportunities for seniors on November 10th.
- Counselors attended grade level intervention meetings.
- Several new students enrolled at Oregon High School during the month of November. Counselors supported their enrollment and transition to OHS.
- Counselors met with students individually for counseling.

District Student Services

- The District Student Services Team met via Zoom on November 19th.
- An additional question was added to the daily parent certification. This prompt allowed parents to request a social worker/counselor check-in with their child. Student services personnel checked in with students based on these requests.
