# **September 2021 Monthly Report**

### **Oregon Elementary School**

- Mrs. Stewart facilitated 70 classroom lessons in Pre-K through 2nd grade. Topics included: personal space, empathy, friendship, kindness and respect, and responsibility.
- Mrs. Stewart facilitated 7 Social Emotional Learning (SEL) groups in Mrs. Thomas and Mrs. Costa's rooms, lessons focused on listening and the brain.
- Mrs. Stewart started 3 lunch groups with students in 1st and 2nd grade with approximately 6-8 students per group.
- Mrs. Stewart had 65 individual student meetings to address individual needs of students. Mrs. Stewart did a home visit for a family who lost a parent. Mrs. Stewart also has been working with DCFS in regards to several student concerns.
- Mrs. Stewart also met with all 5th and 6th grade homerooms to discuss Student Ambassadors for the school year.
- Mrs. Stewart's meetings: Student Services Meeting, SAT meetings K-2, Schoology training, Leader in Me (LIM) action team, multiple student teamings, monthly staff meeting, parent meetings, Student Ambassador Committee.

#### David L. Rahn Junior High School

- Mrs. Cermak completed individual check in meetings with 8th graders in September.
- One new 504 plan was developed and two existing 504 plans were reviewed with teams.
- Collaboration with SEL Interventionist to provide support for students.
- Began academic supports including check and connect and individual meetings with students.
- Meetings in September included: grade level meetings, Leader In Me, and Professional Learning Community (PLC) planning for Service Day/Grade Recovery Day.

### **Oregon High School**

- Senior meetings wrapped up during the month of September with Mr. Turffs and Ms. Cremeens.
- Mr. Turffs began senior group meetings during Hawk Huddle to talk about the Free Application for Financial Student Aid (FAFSA). Ms. Cremeens began 9th and 10th grade College and Career Readiness group meetings during Hawk Huddle to talk about careers and options after high school. These will continue into the month of October.
- The Oregon High School (OHS) Counseling Office established a weekly meeting to discuss programming and monitor their goals for the 2021-2022 school year. Additionally, all OHS Counseling Office staff are a part of a Behavior Assistance Team (BAT) that established a weekly Monday meeting to address and monitor students requiring Tier 2 or 3 behavior interventions due to situations such as mental health, attendance, or discipline.
- Mr. Turffs attended Counselor Meetings at Rock Valley College, Sauk Valley Community College, and Kishwaukee College.
- OHS Counseling Office provided individual counseling supports to students in crisis/requiring check-ins re: academic and social-emotional concerns.

#### **SEL Interventionist**

- @ David L Rahn (DLR) Ms. Peterson had 79 individual student contacts, 11 parent contacts
- @ DLR Ms. Peterson has daily morning check-in's with 3 students to review attendance goals. All 3 student's attendance have improved!
- @ DLR Ms. Peterson is holding weekly lunch groups to cover basic social skills. Currently have 2 separate lunch groups.
- @ OHS Ms. Peterson had 65 individual student contacts, 8 parent contacts
- @ OHS Ms. Peterson is starting to schedule appointments with students who have 504's to check-in and make sure they are comfortable with their accommodations, see if they feel they need any additional support.
- @ OHS Ms. Peterson attends weekly BAT meetings.
- On October 8, 2021 Ms. Peterson attended a training at OCEC regarding topics such as; Student discipline, section 504 plans and eligibility, and new legislation to be aware of.
