January 2021 Monthly Report

Oregon Elementary School

- In January Mrs. Stewart was out for an extended period of time however during that time she did continue to do lessons remotely and attend meetings. January was Kindness Month at OES so all of the lessons in Pre-K through 2nd grade focused on kindness. Mrs. Stewart facilitated 44 classroom lessons in Pre-K through 2nd grade. She held 2 groups in Mrs. Costa's room that was focused on brain development and "flipping your lid" which talks about emotional regulation. She also met with 8 students for individual meetings that focused on self-esteem and self-regulation. Mrs. Stewart attended several parent meetings this month as well as the Student Services Meeting, staff meeting, BSAT meeting, student BSAT meeting, Jr. Kindergarten meeting, student transfer in meeting, and the diversity book club meeting.
- Mr. Montanola met with 40 students several times for individual counseling. He four two philosophical discussions. He also taught 47 SEL/ teaching thinking, decision making and problem solving. In addition, he provided 126 individualized student work classroom interventions, and contacted 10 parents via phone call. He worked with 60 remote learners for S. E. L. He shared animation videos having to do with willpower and independence. While people in quarantine, he assisted the nursing staff by taking temperatures and subbed teaching for one day.

David L. Rahn Junior High School

- Mrs. Cermak continued to meet with students virtually and in person and provided orientation for two new students.
- Meetings in January included IEP meetings (Chana and DLR), parent meetings, PLC, truancy, and department meetings.
- Started training for Schoology pilot.
- Began planning for high school registration appointments and IAR schedule.

Oregon High School

- Counselors worked to coordinate students for an intervention day upon return to the second semester, then identified students for consistent interventions with mentors/credit recovery for the Spring 2021 term.
- Counselors meet weekly with grade level teams to determine intervention needs.
- Counselors worked with administration to finalize the 2021-2022 Course Guide.
- Counselors recorded a virtual 8th Grade Course Information Night presentation that was sent to all students/families in place of the annual in-person event. 8th Grade meetings begin in February.
- Counselors began meeting with students individually to register for 2021-2022 course requests.

District Student Services

- On January 21st, members from the District Student Services Team met to review goals and to provide monthly updates.
- Counselors/Social Worker met with students based on parent requests for a social-emotional check ins.
