#### **StudentTracker Reports**

We have used the StudentTracker project to follow students in their postsecondary enrollments since the 2010-2011 school year. In our initial data file, we went all the way back to the Class of 2004 so we could have historical data from the start. Every November, the National Student Clearinghouse matches our graduates file with current college enrollments and sends us a new report. The new reports, including the Class of 2021 and enrollments from the 2021-2022 school year, are attached.

- Postsecondary enrollment suffered a very large decline in Fall 2020 as students who would normally begin attending college did not, likely due to the early months of the COVID-19 pandemic
  - $\circ$  37% for the Class of 2020
  - 51% average over all years
  - Decline more pronounced for 4-year schools
  - Many of these students did start college by the Fall of 2021
    - 46% for the Class of 2020
    - Still below the average of 62% across all years
    - Class of 2020: 37% in year one, 46% by year two
    - Class of 2019: 51% in year one, 56% by year two
- The four community colleges in our area continue to the most frequently attended
- Illinois State University is the most popular in-state 4-year school
- UW-Platteville is the most popular out-of-state 4-year school






