Oregon Elementary School

- Mr. Montanola met with 60 students individually. He ran 24 philosophical discussion groups, 10 SEL/social skills groups, one peer conflict group with a total of 103 students and 84 individualized student work in class interventions. Furthermore, he attended two full days Leader in Me Seven Habits training sessions in Chicago.
- Mrs. Stewart held 56 individual student meetings this month. Mrs. Stewart also conducted 57 classroom lessons in pre-k through 3rd grade. Topics focused on personal space, sharing/taking turns, listening/following directions, respect, and starting the unit on emotions in all levels. Student Ambassadors have also been selected for 5th and 6th grade this year, meetings are being held weekly during lunch. The buddy bench project from last years Student Ambassadors is officially complete, the benches have been placed on the playgrounds. Mrs. Stewart also attended the grade level SAT meetings this month, multiple IEP meetings, BSAT, and has also spent a significant amount of time collaborating with our teachers and staff to help several of our higher need students be successful in the building.
