September 2020 Monthly Report

Oregon Elementary School

-Mrs. Stewart met with 40 students for individual meetings this month due to crisis situations and social emotional concerns. Mrs. Stewart also facilitated 57 in person classroom lessons and 12 virtual lessons this month. Topics this month included: Personal space, masks, germs, hand washing, diversity, respect, manners, and emotions. This month we started covering the Zones of Regulation with students in K-2 to start off our emotions unit. The lessons are also being posted weekly for our remote learning students in Google Classroom. Students in grades 1-6 also completed the needs assessment that was developed by our Student Services team to assess current needs and concerns as we transitioned back to school. Mrs. Stewart has also been in communication with parents and families to address current needs and concerns. She also attended the following meetings: PLC meeting, CPI training, Student Services, ROE Counselors, and SAP services meeting.

- Mr. Montanola met with 38 students several times for individual counseling. He ran ten philosophical discussions. He also taught 61 SEL/ teaching thinking, decision making and problem solving. In addition, he provided 105 individualized student work classroom interventions, and contacted 10 parents via phone call. Out of 58 remote learners, he worked with 40 for S.E.L. He shared animation videos having to do with diversity among other related subjects. Furthermore, he is working with Mrs. Gadow, Mrs. Tomlinson, Mrs. Stewart, Mrs. Ramirez and Mr. Mendoza to create a group of staff members to address diversity in the school.

- Mrs. Cermak continues to support Mrs. Cermak continues to support students' social-emotional needs by meeting individually and in small groups.
- DLR welcomed two new students in September: Mrs. Cermak provided orientation to their families and scheduled students.
- Meetings this month included: parent meetings, IEP meetings, PLC and grade level meetings, ROE Counselor & Social Worker Networking meeting.
- One home visit was made with our School Resource Officer.

Oregon High School

- Counselors at DLR and OHS completed a crosswalk to demonstrate power SEL standards to be completed in the school.
- Counselors worked with Mr. Larsen to create a new format for honors classes which provided ease to teachers and consistency in reporting on transcripts for colleges.
- Counselors collaborated with ISAC to host a Financial AID information night virtually to 6 families on September 29th. A FAFSA Completion Night will be coming up in October, along with a college application day in October.
- Mr. Turffs coordinated the senior SAT held on Wednesday, September 23rd. This was for the Class of 2021 who missed their opportunity to test last April.

District Student Services

- 7-12 Counselors attended a College and Career Readiness vertical meeting on September 9th.
- The District Student Services Department met on September 17th for a monthly meeting.
- A needs assessment was given to all OCUSD students with questions regarding their feelings of safety at school related to COVID and equity this fall. Additionally, questions were asked to gather information on feelings of safety, support and security during the stay-at-home order. Counselors and social workers viewed results and scheduled meetings with students showing current or previous concerns to support their emotional well-being and any physical needs.
