### **March 2020 Monthly Report**

#### **Oregon Elementary School**

- Mr. Montanola met with 38 students a few times for individual counseling. He ran 20 philosophical discussions, 13 SEL/ social skillstreaming groups, and one peer conflict group. In addition, he provided 58 individualized student work classroom interventions, and contacted 28 parents via phone call.
- Mrs. Stewart had 15 individual meetings with students. She also facilitated 4 lunch groups for SEL and Student Ambassadors. Mrs. Stewart facilitated 28 classroom lessons in Pre-K - 3rd grade, many of these lessons were on the topic of careers and career exploration and most recently completing classroom check-ins via zoom. Mrs. Stewart also attended the monthly SAT meetings for her grade levels and attended 5 parent meetings and is reaching out to parents via phone/texting/email/Class Dojo/Remind/Seesaw to provide parent support.
- Mr Montanola and Mrs. Stewart both assisted with the food and materials assembly and delivery throughout the district.

**David L. Rahn Junior High School**

- Mrs. Cermak met with students individually and in groups while school was in session.
- Met with parents and participated in 2 IEP meetings at DLR and one IEP meeting at OES.
- During the first week of e-learning students and parents were contacted by email for check-ins to determine needs.
- Master schedule for 20-21 work is in progress (course placement for honors level and IEP students and daily bell schedule).

**Oregon High School**

- Counselors finished up 8th grade student scheduling meetings the week of March 2nd.
- Counselors began to discuss and determine sections/teachers for master scheduling.
- Counselors planned a “Scholarship Curbside Drop-off” Day for the first week of April for a safe way for scholarships to be returned.
- Counselors complete student check-ins during e-learning time to support those in need of meals/computers/packets/etc. and to support teachers who had not heard from certain students the first week into e-learning.

**District Student Services**

- On March, 5th, District Counselors and OCEC Staff met to review updates for the department.
- On March 16th, District Counselors met to review resources for social and emotional support, created a special Facebook page, and created a Q&A for resources online
- On March 30th, District Counselors/OCEC Staff met via Zoom for a weekly planning meeting and check-in. These will continue each Monday during the e-learning time.
