### **April 2019 Monthly Report**

#### **Oregon Elementary School**

- Mr. Montanola met with 45 students several times for individual counseling. He ran 22 philosophical discussions, six social skillstreaming groups, and three peer conflict groups. In addition, he provided 105 individualized student work classroom interventions and did three home visits.
- Mrs. Stewart had approximately 70 individual meetings with students this month for social emotional concerns, academic concerns, and the need for breaks. Mrs. Stewart also provided 30 classroom lessons for pre-k through 3rd grade, she has also been going to the DLR pre-k weekly to complete lessons for the afternoon class as well. Many of the lessons this month were focused on career exploration for all grade levels. Mrs. Stewart also held 11 social-emotional groups during lunch for grades K-3, self-esteem and boundaries were common topics this month. She also held 5 Student Ambassador meetings during lunch time, the focus this month was the fundraising for buddy benches. Ambassadors were busy making painted rocks for our fundraiser opportunity at Fine Arts Night and the Talent Show. Mrs. Stewart and several representatives from the Student Ambassadors also presented at the April board meeting. Mrs. Stewart also attended the Illinois School Counseling Association Conference with Mrs. Cermak.

**David L. Rahn Junior High School**

- Mrs. Cermak continues to meet with students individually and in small groups.
- Meetings this month included grade level meetings, Student Assistance Team meetings, student services department, many IEP meetings at OES and DLR, Nachusa campus meetings, meetings with parents, PaCE team at OHS and Service Day committee meetings.
- Continued work on DLR master schedule and worked with teachers to determine student course placement for 19-20
- Testing coordinator for Illinois Assessment of Readiness, Supervised all make-up testing and off-campus testing
- Attended Illinois School Counselor Association Annual Conference with Mrs. Stewart
- Began "The Leader in Me" book study with DLR staff.

**Oregon High School**

- Mr. Turffs coordinated SAT/PSAT 9 and 10 testing schedules for test administration on April 9, 2019 and make-up test date April 23, 2019. Ms. Cremeens coordinated accommodations testing rooms for students with approved accommodations. Ms. Turffs coordinated all pre-testing sessions prior to the test date.
- Counselors attending the Problem Solving Team meetings throughout the month of April.
- Ms. Cremeens held two group counseling sessions.
- Counselors worked on the master schedule for the 2019-2020 school year and student schedules.
- Ms. Cremeens attended EOY meetings for students who attend school at the Nachusa Campus.
- Ms. Turffs prepared for AP Testing in May 2019.
