Board members,

I write this letter in an effort to have you better understand my decision to request being reassigned from head wrestling coach to assistant. In the fall of 2016 I was asked by Mr. Lawton to assume the head coaching position for Oregon Wrestling. I knew there was work to be done and I told myself once we get this program re-established I will hand it off to the next best candidate.

My belief is the program has certainly reached a point of being re-established, with four state placers in the spring of 2019 and two state placers in the spring of 2021 including a state runner-up. The Hawks consistently place as a team in the multiple varsity tournaments in which we compete and our lower level schedule has been strengthened considerably in working with Mr. Lawton. In short, the Hawks are poised to continue to compete at a high level moving forward.

In the fall of 2019, in preparation for this eventual move, I named Justin Lahman as associate head coach. This was done to eliminate any confusion amongst the staff regarding who was being groomed as the next head coach. Over the past twelve seasons, Coach Lahman has been a constant for these kids working under three different head coaches. It is now his time to take the reins and lead this program.

At an August 19, 2021 coaching meeting, our staff collectively decided that Coach Lahman would transition into the head coaching position effective immediately, pending approval from Mr. Lawton. It was further agreed I would remain as an assistant coach and continue to mentor Coach Lahman, specifically with regards to all the paperwork and behind the scenes details I routinely complete. These details will be slowly released to Justin over time. I love these kids and I love this program and look forward to remaining a part of it as an assistant.
