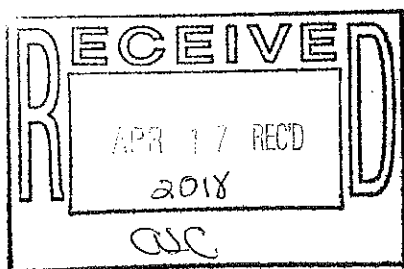
To Superintendent and School Board,



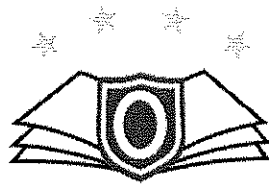
I thank you for your understanding in this exciting situation! My husband and I are looking forward to bringing our bundle of joy to visit once he or she arrives.
