April 2021 Monthly Report

Oregon Elementary School

- Mrs. Stewart facilitated 57 classroom lessons in Pre-K through 2nd grade. The lessons in Pre-K, Kindergarten, and 1st grade focused on careers this month. Mrs. Stewart would like to thank Dr. Mahoney, Officer Kalnins, Lindsey Breeden, Kelly Pace, and Anna VanDyck for coming in and speaking to the 1st grade classes about their roles in our district. In 2nd grade, the lessons focused on teasing, conflict, and bullying. All of the lessons are also shared with remote learners via Google Classroom. Mrs. Stewart met with 50 students for individual sessions focusing on social emotional needs.
- Mrs. Stewart facilitated 3 groups this month that focused on emotional regulation.
- Mrs. Stewart attended the following training/meetings: CPI Refresher, BDAT Meeting, Staff Meeting, Diversity Meeting, BSAT, Jr.
 Kindergarten Meeting, Student Services Meeting, multiple parent meetings, and multiple student teaming meetings with staff and outside service providers.
- Mr. Montanola met with 26 students several times for individual counseling. He also taught 40 SEL lessons that focused on visualizing thinking. In addition, he provided 136 individualized student work classroom interventions, and contacted 9 parents via phone call

DLR Junior High School

- Mrs. Cermak continued to meet with students virtually and in person and provided orientation for two new families.
- Meetings in March included IEP meetings, parent meetings, PLC, and grade level teams.
- Completed IAR testing and Illinois Science Assessment including testing remote learners at DLR. Only four DLR students did not test for the IAR and one student did not take the science assessment.

Oregon High School

- Students took placement tests for college/college dual credit classes during the month of April. Highland Community College held a session on-campus in April, and they will return in May for a second round.
- Students attended virtual Orientation sessions for Kishwaukee College on Friday, April 9th.
- Mr. Turffs and Mrs. Spratt coordinated SAT Testing on Tuesday, April 13th and PSAT testing on Wednesday, April 14th. Ms.
 Cremeens coordinated accommodations testing for those students with a 504/IEP. Make-up testing was completed on April 23rd by counselors and staff.
- Scholarships were reviewed and work continues to prepare for Honors Night in May.
- Ms. Cremeens worked with science teachers to coordinate the first month of the Rural Healthcare Explorers Program for students interested in the healthcare field. This is a grant in cooperation with the U of IL Rockford extension.
- Mr. Turffs organized and prepared for May's AP Testing.
- Counselors met with students for individual counseling.
